- (2) The management shall not collect any donation from the students or their parents/guardians and collect only the fees prescribed by Government from time to time as per the provisions of the Karnataka Educational Institutions (Abolition of Capitation Fee) Act, 1984 or as prescribed by the Central Board of Secondary Education, New Delhi.
- (3) Children of those belonging to the All India Services/Central Services liable to inter-state transfer, migrants from out of State who are temporarily put up in this State/employees of all India level business/commercial and industrial establishments and Anglo-Indians shall get preference in admissions.
- (4) Admission to pre- primary stage, should be done in the month of April every year.

- (5) The NO OBJECTION CERTIFICATE along with the conditions subject to which the same has been issued should be exhibited in a conspicuous place in the Chambers of the Principal/Head Master/Head Mistress, for the benefit of general public.
- (6) For starting the pre-primary school (Nursery/LKG /UKG etc.,) the management shall obtain prior permission by registering the same in accordance with the Karnataka Educational Institutions (Classification and Registration) Rules, 1997.
- (7) Any other conditions that may be imposed in future.
- (8) Government of Karnataka may take action to withdraw this No Objection Certificate in case any of the conditions is violated.

Boundary Wall: Concrete boundary wall of not less than 6 ft. height, enclosing the school campus/site. Composite boundary walls which are partly concrete and partly grill/mesh/barbed wire below 6 feet will not be acceptable. If fencing/grill is required, then the same should be over and above 6 feet height.
